I. Overview

Forward Careers, Inc. (FCI) has received a Reducing Barriers to Employment & Advancement grant from the United Way of Greater Milwaukee and Waukesha County to provide Certified Nursing Assistant (CNA) training for eligible residents of Waukesha, Ozaukee, and Washington Counties.

Forward Careers will actively recruit eligible individuals to participate in this training opportunity, ensuring a strong candidate pool for the program.

This RFP invites qualified training providers to submit proposals to deliver CNA training services to support participants in acquiring the skills necessary for successful employment in healthcare settings.

The grant award is \$32,000, allocated to train a total of 35 individuals.

II. Target Population

The CNA training program will prioritize individuals with barriers to employment residing in Waukesha, Ozaukee, and Washington Counties. Barriers to employment may include, but are not limited to:

- Economic disadvantages
- Limited access to transportation
- Limited English proficiency
- Disabilities
- Lack of previous work experience in healthcare

Training providers are encouraged to outline their strategies for recruiting, supporting, and retaining participants who face these challenges, ensuring equitable access and successful program completion.

III. Training Program Scope

The CNA training program will focus on:

- Training eligible individuals with barriers to employment residing in Waukesha, Ozaukee, and Washington Counties.
- Preparing participants for certification as a Certified Nursing Assistant.
- Providing all necessary instruction, materials, clinical experience, and exam.

IV. Project Timeline

- Training Start Date: January 13, 2025
- Training Completion Date: June 13, 2025
- Certification Exam Date: To be scheduled immediately following training completion for outcomes by June 20, 2025

V. Eligibility Criteria for Applicants

Training providers must:

- Be accredited and approved to offer CNA training in Wisconsin.
- Have a history of successful training completion rates and high pass rates on the CNA certification exam.
- Provide evidence of their capacity to support participants residing across Waukesha, Ozaukee, and Washington Counties.

- Adherence to Grant Requirements: Describe how the program will align with the grant's specified participant demographics and maintain regular communication with Forward Careers to effectively support participant needs and promote successful outcomes.

VII. Evaluation Criteria

Proposals will be evaluated based on:

- Program design and alignment with CNA certification standards
- Organizational experience and capacity
- Cost-effectiveness
- Understanding of demographics to ensure success.
